Chairman's Report

I am delighted to present the St John Ambulance Victoria Annual Report which charts our progress and achievements in 2018.

In a vear characterised by Royal Commissions and inquiries, a common thread identified in some of these ethical and cultural organisational failures has been the erosion of trust by the community in institutions. In this challenging climate, St John is an organisation which is not suffering from a lack of trust. While we are not perfect, we do enjoy the confidence and the trust of the community we serve. Our very existence in the Victorian community is reassuring to our community because we are trusted.

2018 has seen our Board engage with the executive team on developing our Strategic Plan for the next 5 years.

Our focus has been on increasing our capacity to deliver community health programs through diversifying and strengthening our commercial enterprises. Each of our community programs is underpinned by an ultimate purpose to save lives through First Aid and we are certainly focussed on developing and delivering more community programs which align with our mission and our organisational strengths. We look forward to engaging with all of our stakeholders in the launch of our Strategic Plan in early 2019.

Our existing community programs remain a source of great pride to the organisation. Our flagship program, First Aid in Schools together with our mobile CPR Lab, provision of debrillators to sporting groups and our Community Transport Service actively represent our ongoing commitment to the service of many thousands of members of the Victorian community.

We were delighted this year to sign up to the GoodSAM app, in partnership with Ambulance Victoria. The GoodSAM app connects trained first aiders and health professionals with people suffering cardiac arrest nearby them in the community. It has already saved lives and is a tremendous example of the use of technology, collaboration between organisations and the service of individuals.

Each of our community programs and our capacity to develop new programs depends upon the success of our commercial operations which encompass training, product sales and non-emergency patient transport. Each of these operations continues to perform strongly in the face of challenging market conditions and engagement with significant technology projects which will underpin our growth and revenue diversification.

Our 2300 volunteers are the face of St John at public events and emergencies and at the heart of our organisation. In 2018 our volunteers attended more than 4600 events and emergencies giving more than 319,000 hours of their time to serve the Victorian community. Our volunteers are highly engaged and member numbers are increasing with an enviable level of gender and age diversity. Senior volunteer members together with our staff have led a renewed focus on our clinical governance framework which is critical to our continued leadership in the areas of Event Health Services and Non-Emergency Patient Transport and our delivery of quality personcentred care.

Our relationships with key members of the State government and the Opposition together with members of the National Board and executive of St John Ambulance Australia have

strengthened through regular contact and invitations to events and for site visits. We believe that St John should play a key role in assisting government to develop sound policy in relation to emergency response and First Aid Services and will continue to advocate and provide thought leadership in this area. Our Board continues our commitment to national collaboration for the mutual benefit of each member of the St John federation and most importantly for the continuation of our mission in the service of the wider Australian community.

During 2018 we were delighted to welcome Dr Andrea Diamond as a member of the Board. Andi is the CEO of City of Monash and has

significant experience as an executive and company director including as President of the Metropolitan Fire Brigade. I am indebted to Andi and all of my Board colleagues - Mark Engel, Rod Collins, George Braitberg, Caroline Elliott and Paul Davidson for their ongoing support, wise counsel and commitment to St John Ambulance Victoria throughout 2018.

As we enter 2019, it is timely to remember that the trust which the community has placed in St John Ambulance Victoria is built upon our shared organisational and individual commitment to our underlying mission - the service of humanity. Whether as employees or volunteers, the way that we deliver first aid or deliver care, even the smallest acts of kindness and service to others, embody our mission and generate true hope and optimism in the communities we serve.

Chief Executive Officer's Report

I'm pleased to report that in 2018 we delivered on our mission to save lives through First Aid — and assist those who were in sickness, distress, suffering and danger.

St John Ambulance Victoria is a diverse organisation, dedicated to serving the Victorian community.

As you read this annual report I'm confident that, like me, you'll be inspired by our people and all they have achieved over the last year.

Whether it's a First Aid volunteer assisting at an event, a customer service officer selling a defibrillator, a trainer educating a First Aid class or an ambulance attendant moving a patient, everyone contributes to our purpose in their own important way.

We are blessed to have so many people devoted to the service of others through our mission.

In 2018 our Event Health Service volunteers attended 4,690 events across Victoria and treated 51,314 people – from those who simply needed a band-aid to the acutely ill.

The growing use of drugs at music festivals has required our highly-trained volunteers to provide more lifesaving interventions than ever before. Thanks to their fast response times and leading clinical practices, they saved 11 young lives at music festivals this year.

These incredible acts of service are seldom noted in the media. However, I would like to acknowledge them and say thank you – as I do to all our volunteers who, so tirelessly, keep our community safe.

In recognition of our superior capabilities and customer-centric

approach, St John Ambulance Victoria retained the First Aid service contract at Marvel Stadium for a further five years. In fact, we have resecured all our major venue contracts in the last two years.

In 2018 we enthusiastically supported Ambulance Victoria's GoodSAM app. More than 250 of our volunteers registered their willingness to attend to a person suffering from sudden cardiac arrest near them.

Our other community programs also performed strongly this year, with the following notable achievements:

- > We trained nearly 190,000 primary school children in First Aid free of charge through our First Aid in Schools program
- > We provided free CPR lessons to 14,000 people through our CPRLab program
- > We transported more than 1,000 vulnerable people to doctor's appointments or helped them get home through our Community Patient Transport Service (which we only recently launched in late 2017)

I extend my heartfelt appreciation to everyone who helped make these community programs possible.

Another highlight this year was the launch of our First Aid Action Hero game – a fun and engaging way for children to learn First Aid. In just a few weeks, more than 5,000 children around the world downloaded and played this free game. We hope it will give them confidence to help

their friends or family in a medical emergency if ever needed.

This year we also continued our partnership with the Department of Health and Human Services by delivering nearly 400 subsidised defibrillators to Victorian sporting clubs. Each unit is a potential lifesaver for those communities. This milestone completed our initial commitment of 1,000 defibrillators. However, I'm pleased to confirm that the Department has extended the program by another 400 units.

The men and women of our transport services fulfil our mission to serve humanity daily. Our ever-caring Patient Transport team moved 26,374 people on behalf of Ambulance Victoria, Peninsula Health and St Vincent's Hospital. Meanwhile, our Deceased Persons Crew moved more than 7,500 deceased persons with dignity and compassion.

It's my honour to acknowledge the service of our volunteers. Our annual parade at Government House is one of the small ways we say thank you, and this year's event was exceptional.

I also congratulate everyone who was admitted and promoted in the Most Venerable Order of the Hospital of St John Jerusalem. The Investiture is an occasion rich in historic observance.

Another highlight this year was our inaugural First Aid Champion Awards. This event gave us the opportunity to acknowledge everyday Victorians who

have used their First Aid skills to save a life or help someone in need. The recipients' heart-warming stories were testimony to the importance of people being prepared to provide First Aid in the community. I look forward to this event growing in significance over the years to come.

In 2018 we were beneficiaries of a \$1.1M bequest from the estate of the late Jean Stewart – a long-time donor of St John Ambulance Victoria. We are thankful and humbled by her generosity. Thank you too, to our many other donors and supporters. Every gift and grant helps.

From a commercial perspective, 2018 required hard work and focus, and our revenue grew modestly by 6% to \$34M.

We are blessed to have so many people devoted to the service of others through our mission.

Accounting for 32% of total revenue, product sales was the standout with 7% growth on 2017. This was primarily driven by an increased demand for defibrillators – an encouraging indication that the message is finally spreading.

We trained 52,500 people in First Aid and experienced strong growth in our corporate onsite training. However, overall training numbers were down.

We continued to invest in a number of digital transformation projects which increased our costs as expected.

Designed to help us become a more customer-centric organisation,

these projects will give our staff and volunteers the tools they need to become more effective and efficient.

This year we also reactivated our Chaplaincy Program – as we welcomed Reverend Jim Pilmer to the organisation. His vast experience working with the Police and other agencies has been a great benefit to us. Many of our volunteers and staff have found it easy to reach out to him for support thanks to his warm, approachable manner.

During the year the Board and Executive Team came together to work on the Strategic Plan 2019 – 2023. By the time this report is published, we'll have launched the plan with our staff and volunteers, as well as our business, government and community partners.

Centred on our broad mission For the Service of Humanity, the plan has the following four priorities:

- Maximise our Community Health Contribution
- 2. Diversify our Commercial Activities
- 3. Deliver Person Centred Care
- 4. Inspire our People

We have made strong commitments within each priority, and these will be integrated into our future business plans. The Strategic Plan communicates an exciting vision and I encourage everyone to get behind us as we seek to have a greater impact on our community.

As always, I thank our Chairman Virginia Bourke for her enormous contribution and wise leadership. She is always available and responsive whenever we need her. My appreciation also goes to all Board members who provide guidance, keep us accountable and give their time to make sure we are well governed and on purpose.

Lastly, it's a privilege to work with an Executive Team whose dedication to our mission is absolute. Thank you to each of you for your hard work, leadership and support.

Looking ahead, 2019 is set to be a year of growth and innovation.

To begin with, Ambulance Victoria has shown its confidence in our abilities as a Non-emergency Patient Transport provider by significantly increasing our workload under a new contract which begins in July. Ambulance services are in our blood, so it's stirring to see this part of our organisation grow.

We also plan to launch a new style of First Aid training in the coming year. By educating the public and our commercial customers in more creative and engaging ways, we believe they will be better equipped to assist others in a medical emergency.

Thanks to these and many more exciting initiatives we have planned, I am confident that 2019 will be a success in our Service of Humanity.

Event Health Services

Event Health Services enjoyed steady growth in 2018, with increased community demand and volunteer participation. Although they faced more challenging cases than ever, our First Aid responders delivered the same high level of professionalism and care that St John has been known for for over 135 years.

Volunteer Performance

St John volunteers provided almost 130.000 hours towards Event Health Services in 2018.

This is a staggering level of commitment from the community - to the community.

They also undertook a record number of lifesaving intubations (12) and a substantial number of resuscitations (7)

Led by our Event Health Services team, the St John Community Transport Service enjoyed strong growth in 2018. Offering an exciting new volunteering opportunity within St John, we expect this wonderful service to grow further in 2019.

We delivered an enhanced ePCR portal which has been well received by customers.



Voice of the Customer program

This year we launched our new 'Voice of the Customer' program.

Using a post-event survey, we are now drawing meaningful feedback from customers on their personal experiences with St John. This data is already giving us a deeper insight into our customers and new ideas for how we can enhance our service. It's also allowing us to identify and acknowledge the strong performance of specific Event Health Services personnel.

Revenue growth

During May to September 2018, St John deployed more volunteer and paid workforce hours – and achieved a higher overall revenue – compared to the same period last year.

This was due to a targeted strategy to increase opportunities over this traditionally quiet period.



In 2018 we continued to engage young people (12–17 years) in our First Aid-oriented youth program. Designed to meet the future needs of our community and St John, this initiative contributes to our goal of saving lives through First Aid.

Continual improvements

This year we introduced a new system to improve how we manage parent contact details, fee payments and health information for our youth members.

The new online platform is already improving internal efficiencies, health condition management and parent communication.

During the year, we also produced a new guide and resources to help our youth staff improve behaviour management and support the safe, positive participation of our youth members.

Competition success

Christine's contribution to the St John Youth program has allowed hundreds of young people to learn life-saving First Aid skills and realise their leadership potential.

Annual Report 2018





Representing 54% of our total revenue in 2018, our product sales and training services continue to drive the financial success of our organisation.

THESE INCLUDE THE:

- > Delivery of accredited and non-accredited First Aid and allied training courses online and offline (in workplaces and through St John training venues across the state)
- > Manufacture and supply of First Aid kits for homes and businesses, distributed directly to the public and via retail channels
- > Supply of health-related equipment including defibrillators, monitors and consumables

Thanks to these commercial services, St John remains in a strong long-term position to deliver and grow our vital community programs.

Sales and business development

We are pleased to report that our Business Development team exceeded its sales targets for 2018.

During the year we also implemented a number of changes, including:

- > Appointing a new sales manager who oversees the sales, call centre and kit servicing teams
- > Implementing Salesforce CRM

Product sales

St John experienced solid growth in First Aid product sales in 2018, with a 7% increase on last year.

Key highlights included:

- > The delivery, installation and training of defibrillators to 416 sporting clubs as part of our Department of Health and Human Services and Fisheries contracts (representing a 6% increase on 2017).
- > The insourcing of our manufacturing and warehousing operations which improved our efficiency and integrated logistics activities across our training and transport services.





Training courses

We trained 52,587 people at workplaces and St John training venues in 2018.

Although this represents an overall decrease of 5% on 2017, our core public course performance was on par with last year. The decrease was due to a decline in our non-core course performance.

What's more, we saw 6.5% growth in our regional training participants.

In late 2017, we lost a major corporate customer, which has impacted the total number of people trained this year. If we were to

exclude this customer from last year's calculations, our corporate training numbers actually increased by 9.5% in 2018.

We also experienced strong growth in several courses, including Mental Health, Asthma and Anaphylaxis, and Child Care First Aid.

In 2019 we will continue to diversify our training offerings and invest in significant improvements to our delivery. This will ensure we continue to provide industry best-practice training and outcomes – and give participants confidence to use their First Aid skills in medical emergencies.

Transport Services

Committed to growing this important community service in 2018, we are pleased to report that we moved 26,374 patients throughout the year – a 4% increase on 2017.

Non-emergency Patient Transport

Our service levels continued to meet or exceed our clients' expectations.

A significant milestone this year was the success of our major tender submission for Ambulance Victoria. St John was awarded a significant increase in our workload, which will begin July 2019. As part of this new contract, our geographic footprint will extend to Geelong, Ballarat and western Melbourne.

This year we also delivered our Non-emergency Patient Transport course (Certificate III) to 21 participants.





Coroners Court contract

Now in its third year, our Coroners Court contract remains integral to our mission: Service of Humanity.

This year we completed 4.9% fewer cases than 2017 (5.4% fewer in metro areas and 3.5% fewer in regional areas).

However, our on-time performance improved in 2018, which was at 92% for metro cases.

We also improved in regional areas, completing all cases on the same or next business day (unless otherwise requested). This was a solid increase on 2017, where we completed 4% of cases the next business day plus one.



Many donors have been giving to our organisation for over 20 years. They make such a difference to our work, helping to continually train and equip our volunteers and grow our community programs.

This year the late Jean Stewart left an incredible gift in her Will to support our volunteers. This was the largest bequest we have ever received – and it will make a significant difference to our organisation for many years. That said, we appreciate every Gift in Will, all of which enable us to continue saving lives.

We are also proud to acknowledge the Ken and Rosie Day Foundation for their generosity this year. They made a generous contribution to our First Aid in Schools program and our new First Aid Action Hero app.

We implemented two direct mail appeals. Our Tax Appeal featured Sam and Connor who saved their mum's life

... we appreciate every Gift in Will, all of which enable us to continue saving lives. after attending our First Aid in Schools program – and our Christmas Appeal featured Sharon Carpenter, a longserving St John volunteer.

Late 2018 also saw the launch of our first Regular Giving Appeal, a critical component of our fundraising growth plans in the years to come.

Finally, our Grant Program remains the backbone of our fundraising strategy. During the year we received 23 grants from various philanthropic and government bodies. These grants funded equipment and volunteer vehicles – and enabled us to reach more primary school students through our First Aid in Schools program.

Community Programs

At the heart of our mission, educating and empowering the community with first aid knowledge and the skills to save a life is an important part of our work.



This year we recognised the need to evolve and expand our program to reflect changing community needs.





Our thriving flagship program: First Aid in Schools

Now in its sixth year, First Aid in Schools reached new heights in 2018 – connecting the community with our mission more strongly than ever before.

From Portland to Mildura to Sale, our passionate presenters delivered training at schools across Victoria to a record 188,399 primary students throughout the year (just shy of our 200,000 target).

This year we recognised the need to evolve and expand our program to reflect changing community needs. Specifically, we have now branched out beyond the formative DRSABC modules to include Anaphylaxis, Asthma, Cuts and Grazes, Bites and Stings, and Burns.

We held an official media launch for our program expansion at Port Melbourne Primary School in June, where a staggering number of students (more than 35) suffer from anaphylaxis or a severe allergy.

Students and teachers across the state have already shared their positive feedback on these changes. This has spurred us to further innovate and adapt First Aid in Schools in 2019 and beyond – a critical requirement for any program to thrive.

During 2018 we also delivered the program to special developmental schools for the first time in several years. This truly ties us to our mission in the service of humanity, which does not discriminate.

Thank you to the many people involved in delivering our flagship program. We are very proud of your hard work and dedication.

We look forward to First Aid in Schools progressing even further in 2019 – and hearing more stories of little heroes like the ones on the opposite page.

Sam and Connor, aged 10 and 8, completed our First Aid in Schools program at Miners Rest Primary School early 2018.

That's why they knew exactly what to do when their mum Sarah suddenly collapsed to the kitchen floor a few weeks later.

Staying calm, Sam rang Triple Zero immediately – and together the brothers checked for signs of breathing before moving their mum into the recovery position. Connor then waited outside for the ambulance while Sam stayed to monitor her condition.

Sarah was taken to hospital in the ambulance and has since made a full recovery. The brothers continue to practise their First Aid skills at home with their mum.



Annalise Vella

A couple of weeks after 12-year-old Annalise completed the First Aid in Schools program at Mackellar Primary School in Delahey, her dad Rodney accidently sliced his arm in a grinder.

Alone in the shed at the time, Rodney passed out and lost lots of blood.

Almost 90 minutes later, Annalise saw her dad and immediately sprang into action.

She called for an ambulance within seconds, before placing him into the recovery position. What's more, she remained calm throughout the entire ordeal.

Rodney believes he wouldn't be alive today if it wasn't for his daughter. Although he may not get full movement back in his hand, he is recovering extremely well.

By the end of the year, a pleasing 5,379 users downloaded the game. That means thousands more children all over the world (from the Philippines, Brazil, South Africa and more) now know how to check breathing, place someone in the recovery position and call for help.

An important contribution to our mission, the app is free and available from the Apple and Google Play stores.

We're planning more innovations to the app in 2019 to keep the game current and engaging.

A community life force: CPRLab

After only three years of operation, CPRLab taught a total of 13,931 people CPR in 2018 – which is an incredible feat.

Present at all types of events, from the Grand Prix to Good Friday Appeal, CPRLab has successfully spread the St John message beyond those who have been formally trained.

The program has become a community life force and a public symbol of St John.

Training

We now receive regular demand from event organisers and venues of all types – especially shopping centres including Westfield.

Throughout 2018 we set out to travel far and wide to support regional areas, where cardiac arrest survival rates are at their lowest and CPR knowledge is most needed.

Our trainers travelled to Warrnambool, Tatura, Shepparton, Geelong and Wodonga as part of our inaugural 'Bural Roadshow'.

This year we also trialled defibrillator demonstrations alongside our CPR demonstrations. This was in direct response to our goal of ensuring that 50% of cardiac arrest patients in Victoria receive defibrillation. We'll continue to communicate the importance of defibrillators to all CPRLab visitors in 2019.

After receiving many strong nominations, we awarded the following worthy winners for their incredible acts of First Aid at our ceremony on Friday 7 September 2018.



Victorian First Aid Champion (Overall Winner)

KIRRA WALKER (19), ROMSEY

Just after completing a First Aid training course with St John, Kirra helped four people in life-threatening situations.

Incredibly, all four incidents were unrelated, and occurred over a two-day period.

Kirra performed CPR on her best friend while waiting for an ambulance. She assisted two women having seizures in separate incidents – and also helped a woman in shock following a car accident.



Junior First Aid Champion (Under 12)

SIENNA VULIN (11), BEACONSFIELD

Sienna assisted her mother who collapsed after suffering a stroke one morning.

Calm the entire time, Sienna called Triple Zero, ensured their large dog was put away, opened the gates for the ambulance – and looked after her younger brother throughout the ordeal.



Youth First Aid Champion (Under 18)

ANGUS MANSON (18), NEWRY

Angus was staying with his grandmother Fay one weekend when he heard her coughing and spluttering in the kitchen.

He soon realised she was choking, gagging and becoming anxious. So he quickly jumped into action.

Having completed First Aid training two weeks earlier, Angus performed several airway clearance back blows. This dislodged the peppermint immediately – and saved his grandmother's life.

School First Aid Champion

FATIMA TAWIL & RAYANNE EL HOULI, TRUGANINA

Co-workers and sisters, Fatima and Rayanne helped a student with epilepsy after he bumped his head and suffered a seizure.

Fatima placed the boy into the recovery position while Rayanne came over to assist, helping to control the crowd and calm the other children.





Workplace First Aid Champion

JULIET BUTLER, PAKENHAM

Juliet administered CPR for 12 minutes on a collapsed female at her Community Centre workplace before paramedics arrived.

Thanks to Juliet's quick thinking and immediate action, the woman survived. The CPR saved her life.

We're told that the woman is now in excellent health and continues to visit the centre each week to attend her community group.

Juliet completes CPR training every year with St John.

Community First Aid Champion

ANDY NOTT (19), GLEN IRIS

While jet skiing one afternoon, Andy noticed a capsized boat and quickly sped over.

To his shock, Andy saw a 9-year old boy trapped under the boat. Without hesitation, he placed him on his jet ski and took him to a nearby boat ramp. From there he instructed bystanders to call Triple Zero and performed CPR for almost 30 minutes.

The child made a full recovery with no apparent hypoxic brain damage.

Diversity and gender equality

LEADERSHIP PROGRAM

The 2018 St John Leadership and Future Leaders Program emphasised:

- > Mentoring and coaching
- > Building leadership capacity
- > Developing resilience within changing work environments
- > Creating and contributing to psychological safety within teams and work environments

Our vision statement for this program was 'Care, Connect, Inspire'. This culminated in peer-to-peer presentations that gave participants the opportunity to consolidate and present the information they absorbed during the year.

TEAM BUILDING

St John entered the Police and Emergency Services Games, which was a fantastic team bonding experience.

We competed in Table Tennis, Badminton, Soccer, Beach Volleyball and Athletics – and walked away with four gold medals in Athletics and a silver in Table Tennis.



STAFF RECOGNITION

At the end of 2018, People & Culture recognised a number of valued staff members with our Staff Excellence Awards. These awards celebrated individuals who made an outstanding contribution in customer service, continuous improvement and promoting positive behaviours in our organisation.

Key awards this year included Innovation, Customer Centricity, FISH! (Play, Make their Day, Choose your Attitude, Be There), Our Why and Safety Super Hero.



Child Safety Certification

St John is working towards becoming certified as a Child Safe organisation in 2019.

This milestone will position us as a leader in Child Safety and Wellbeing, and instil the community with confidence that every child in our care is physically and psychologically safe.

Throughout 2018, our Child Safety Certification Working Group Committee made progress on a range of operations and programs. These covered policy, procedures, consultation, recruitment, supervision and performance management, training and induction.



Health and wellbeing (commercial)

This year St John embarked on a new service offering: influenza vaccinations in the workplace.

Introduced on the back of the deadly 2017 Australian influenza season, this new initiative is in direct response to increasing customer and community demand.

Also integral to our ongoing health and wellbeing growth strategy, this program helped to protect our customers – and prevent influenza outbreaks in their workplaces and communities throughout 2018.

As part of this service, we provided simple online appointment scheduling and a professionally-trained nursing team who attended workplaces across Victoria.

Work health and safety

St John introduced a number of safety initiatives in 2018.

One standout was our 'Make a Pact with Safety' campaign, which is part of our ongoing St John Safety Superhero series. This incorporated 'Make a Pact with Ergonomics' as well as 'Make a Pact with Psychological Safety' –

a crucial factor in creating a safe and healthy workplace at St John.

This year we also promoted strategies to educate our people on how to alleviate stress and prevent mental illness. Plus, in our effort to ensure our people feel

supported, we promoted the importance of 'checking in' with colleagues to ensure they are 'OK'.

State Chaplain's Report

Having been appointed State Chaplain on 29th June 2018 my short time with St John has been primarily spent on orientation, learning about the many aspects of the organisation's work and observing the diverse roles performed within it.

My role includes that of chaplain to the Order of St John, with some ceremonial responsibilities, and to St John Ambulance. Prior to my appointment I was privileged to gain some small insight into the wider Australian picture by attending the St John National Convention in Canberra in May 2018.

The early weeks in the role involved briefly addressing the Event Health Services Conference, visiting the State Training Centre, completing a shift as an observer with a Patient Transport crew and attending the Manikato Stakes twilight meeting at Mooney Valley, ostensibly to observe procedures and meet the St John volunteers on duty. I participated in the annual Order of St John service at St Paul's Cathedral in June and represented the Sub Prelate, Bishop Richard Hurford, at a national Priory meeting in Melbourne in November.

A particular focus of my work has been to make weekly

visits to the Transport Branch and the Coronial Services team in particular. This has led to working with Ms Kelly Hartley (People and Culture Engagement Co-ordinator) on the production of a set of guidelines relating to religious

customs and expectations at the time of a death and the potential grief reactions which may be encountered by staff when attending the homes or scenes of deceased people of various Faith backgrounds and cultures.

In December I gave a presentation to Peer Support Co-ordinators on the topic of spiritual support after traumatic events. Increasing my contact with Peer Support members is a priority for 2019.

The overall role of the chaplain is to provide pastoral care and spiritual support to St John staff, volunteers and Order members on a 24/7 basis, regardless of background. The demand for counselling is beginning to grow and it's encouraging to see that some have felt able to approach me with work issues or personal problems. I would like to emphasise that such contacts or visits are totally confidential, usually quite informal, and can be made out of office hours. Informal phone support is also available.

I am most appreciative of the warm welcome I have received as I have begun to explore the St John family. I look forward to deepening that relationship in the year ahead.



A key focus of the Order Affairs Committee during 2018 has been building strategies to further engage Order members in the work and mission of St John Victoria. We look forward to releasing a new program in 2019 to support this.



Financial Overview

St John enjoyed a financially successful 2018. Revenue from our commercial activities and Event Health Services continued to grow on previous years — and we ashieved a healthy surplus. This success allowed us to continue investing in our vital community programs.

Income

As an independent not-for-profit organisation and registered charity, St John is not part of any government agency or authority.

We therefore generate almost all of our revenue through our commercial and fundraising activities.

Thanks to funding from our philanthropic supporters, we are able to continue providing many critical services to the Victorian community. We are also incredibly grateful to the many generous individuals who donated and left bequests to St John during the year.

Our revenue grew 5.4% across the organisation in 2018 – with the following notable achievements:

- > A \$2.2M subsidy towards our range of community programs.
- > First Aid product sales continued to be the standout performer.
- > Our Non-emergency Patient Transport and Coroners Court services both performed to expectations, and continue to achieve best-practice efficiency ratings from the regulator.
- > Customer demand for Event Health Services continued to grow, with a 4% revenue increase on 2017.
- > Fundraising revenue increased thanks to a number of generous bequests and two effective direct mail campaigns.
- > The Commonwealth and Victorian State Governments provided a number of equipment and project grants throughout the year.

2019 outlook

With 2019 being the first year of our new 5-year Strategic Plan, we will centre activities on the key priorities relating to the plan. We intend to:

- Transition into the new Ambulance Victoria Non-emergency Patient Transport contract from 1 July 2019
- Continue to invest in sustainable community projects consistent with our mission

- Invest further in our volunteer recruitment and retention programs to grow membership and engagement
- > Grow our revenue and profit margins through commercial diversification
- > Remain disciplined on costs and opportunities
- Continue to invest in people and other assets to ensure we conduct all activities professionally and safely

Expenses and capital expenditure

St John continued to invest in people and capabilities during the year. Our management team has done another excellent job in maximising efficiency and minimising costs in 2018.

Meanwhile, we invested \$1.6M into capital during the year. Our priority continued to be replacing our ageing software systems, vehicles and equipment.

Highlights include:

- > We commissioned another five vehicles as part of our Event Health Services fleet replacement plan
- > We commissioned an Event Health Services Command Vehicle
- > We replaced our HQ server infrastructure
- > We implemented Office 365
- > We continued to invest in our CRM platform
- > We began the St John Museum redevelopment
